For many years, the North Carolina court system case management application portfolio has relied on IBM mainframe technology, which is more complex to maintain and support. Our new **eCourts** Integrated Case Management System (ICMS) will be vendor supported and cloud hosted making case management and case filings more efficient and effective to access North Carolina justice system applications and data.

The North Carolina Administrative Office of the Courts worked with the National Center for State Courts to convene stakeholders, develop business requirements, and identify vendors. Tyler Technologies' Odyssey suite was the solution selected to help migrate court processes **from** a variety of older applications **to** one integrated case management system.


